CONSULTANT REVIEW

Findings:

- Data conversion error: distribution of future apartment student yields
- HS/MS level: No errors found in projected school-level enrollments
- Aggregated polygon FARM percentages match the school-level FARM reports
- ES level: Propagation of non-integer based school level projection data being propagated out into the integer based planning polygon
 - Known issue, accounted for with adjustment factor

Future recommendation:

 Updated redistricting tool will eliminate future rounding and compatibility errors





OPTION 1: FEASIBILITY STUDY


OUTCOME:

54 schools within target by 2018–19

IMPACT:

Redistrict 8,800 students

- 32 elementary schools, including ES #42 opening
- 19 middle schools
- 11 high schools









OPTION 2a: AAC INITIAL PLAN


OUTCOME:

57 schools within target by 2018–19

IMPACT:

Redistrict 6,500 students

- 31 elementary schools, including ES #42 opening
- 19 middle schools
- 11 high schools

OPTION 2b: AAC ALTERNATIVE PLAN


OUTCOME:

SUPERINTENDENT'S RECOMMENDATION


SUPERINTENDENT'S PROPOSAL

- NO high school redistricting



2018–19 projected capacity utilization


without boundary adjustments





OPPORTUNITIES TO EARN COLLEGE CREDIT WHILE IN HIGH SCHOOL

Option	# Credits	Eligibility
Associate degree	60	Rising grade 9
1 year college + certificate(s) + internship(s)	30	Rising grades 9–10
Coursework earning college credit	< 30	Rising grades 9–11

Advantage to families:

HCC tuition: 50% high school rate

Additional support available for students receiving FARMs

FACTORS:


- No 2018–19 redistricting; next high school redistricting process in 2021
- Expand Early College offerings at Oakland Mills HS; add Early College program at River Hill HS
 - Open enrollment to Long Reach, Centennial and Howard HS students


